It is hereby notified for the information of all concerned that the admission under Choice Based Credit System to Semester-I of the **Three Year (six Semesters) B.A./B.Sc./B.Com. (General) /B.B.A./B.C.A Course** for the Academic year 2017-18 in Degree Colleges affiliated to the University of Jammu falling under **Summer Zone** shall be made as under

- 21-06-2017 to 10-07-2017 (without late fee)
- 11-07-2017 to 20-07-2017 (with a late fee of Rs. 260/-)
- The Vice Chancellor may consider grant of late admission for 10 days only after the expiry of last date as per (b) above on payment of Rs 2400/- as late fee.

The regular teaching work shall begin with effect from 2nd week of July 2017.

ELIGIBILITY CRITERIA FOR ADMISSION to B.A./B.SC./B.COM SEMESTER-I

Admission to Semester-I of the Three Year B.A./B.Sc./B.Com.(General) Course shall be open to a Candidate having passed the Higher Secondary Part-II (10+2 pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education, CBSE or an examination recognized as equivalent there to subject to availability of seats & if otherwise found eligible.

ELIGIBILITY CRITERIA FOR ADMISSION TO B.B.A. COURSE SEMESTER-I

Admission to Semester-I of the Three Year B.B.A. Course shall be open to a Candidate having passed the Higher Secondary Part-II (10+2 pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education, CBSE or an examination recognized as equivalent thereto and has obtained at least 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates.

ELIGIBILITY CRITERIA FOR ADMISSION TO B.C.A. COURSE SEMESTER-I

Admission to Semester-I of the Three Year B.C.A. Course shall be open to a Candidate having passed the Higher Secondary Part-II (10+2 Pattern) examination (in full subjects) of the Jammu and Kashmir State Board of School Education, CBSE or an examination recognized as equivalent thereto with Mathematics as one of the elective subjects and has obtained at least 50% of the aggregate marks in the qualifying examination in case of General category candidates and 45% marks in case of SC/ST candidates.



